Insurance Requirements

Single Family Homes

A. Pursuant to P.L. 2022 c. 92, and any other laws adopted thereafter by the legislatures of the State of New Jersey, institutes a minimum liability insurance requirement for owners of rental units. The law requires owners of a rental unit or units to maintain liability insurance for negligent acts and omissions in an amount no less than \$500,000 for combined property damage and bodily injury to or death of one or more persons in any one accident or coverage minimum

Multi-Family Homes (Duplex)

B. Pursuant to P.L. 2022 c. 92, and any other laws adopted thereafter by the legislatures of the State of New Jersey, institutes a minimum liability insurance requirement for owners of rental units for a **multi-family home**. The law requires owners of a multifamily home which is four or fewer units, one of which is **owner occupied** to maintain liability insurance for negligent acts and omissions in an amount no less than \$300,000 for combined property damage and bodily injury to or death of one or more persons in any one accident or coverage minimum

VIOLATIONS AND PENALTIES

Any landlord who shall violate any provision of the ordinance shall be liable to a penalty of not more than \$500.00 for
