WHEREAS, the budget as introduced is in compliance with the Property Tax Levy Cap Law (N.J.S.A. 40A:4-45.44 et seq.); and

WHEREAS, the Annual Budget as introduced reflects Total Revenues of \$160,853.00 which includes an amount to be raised by taxation of \$151,227.23 and Total Appropriations of \$160,853.00; and

WHEREAS, the amount to be raised by taxation to support the district budget shall be the amount to be certified to the assessor of the municipality to be assessed against the taxable property in the district, pursuant to N.J.S.A. 40A:14-79. Such amount shall be equal to the amount of the total appropriations set forth in the budget minus the total amount surplus and miscellaneous revenues set forth in the budget; and

WHEREAS, in calculating the amount to be raised by taxation, the Fire District has taken into account the assessed valuation of taxable property in the Fire District;

NOW, THEREFORE BE IT RESOLVED, by the Board of Commissioners of the Fire District, at an open public meeting held on December 9, 2025 that the Annual Budget, including all related schedules, of the Fire District for the fiscal year beginning January 1, 2026 and ending December 31, 2026 is hereby approved; and

BE IT FURTHER RESOLVED, that the anticipated revenues as reflected in the Annual Budget are of sufficient amount to meet all proposed expenditures/expenses and all covenants, terms and provisions as stipulated in the Fire District's outstanding debt obligations, capital lease arrangements, service contracts, and other pledged agreements; and

BE IT FURTHER RESOLVED, that the Board of Commissioners of the Fire District will consider the Annual Budget for adoption on December 9, 2025.

The proposed 2026 budget reflects total anticipated revenues of \$160,853, with the amount to be raised by taxation of \$151,227.23 and total appropriations of \$160,853 which is an increase in total anticipated revenues and total appropriations by 15.6% as compared to the 2025 budget. The proposed 2026 budget also reflects usage of \$18,217 from the cap bank available from the 2023 year of \$18,217.

The 2026 proposed budget shows the following variances over +/- 10% as shown below:

Increase in operating grant revenue, supplemental fire service act for \$326 or 100% for approximate amount received each year that has historically never been included within the budget.

Increase in commissioners compensation of \$600 or 50%, for the new resolution including an additional \$600 for the secretary, whom was not subject to compensation in the prior year. The \$1,200 compensation for the treasurer remained the same from prior year.

Increase in office expense by \$4,000 or 100% in order to more accurately reflect office related expenditures incurred from prior year audit report.

Increase in maintenance and repairs by \$16,218 or 70.5% due to the fire district is in need of repairs to help prepare the fire house for expansion for the purchase of a new fire truck, which is planned to be performed in the 2026 year. We may also need to obtain financing to help repair and build the fire house in order to house the new truck. Additionally, the fire house building was erected in 1948 and is always in need in additional repairs and maintenance. This is where the majority of the available cap balance from 2023 is to be utilized.

The proposed 2026 budget reflects the amount to be raised by taxation of \$151,227, which is an increase of \$21,227 or 16.3% in comparison to the 2025 adopted budgeted amount to be raised by taxation of \$130,000. This proposed 2026 amount is in compliance with the property tax levy cap. No funds will be utilized in 2026 from the unrestricted or restricted fund balances. A reserve for future capital outlays of \$38,000 will be made to the 2026 restricted fund balance and will be utilized in help to finance the purchase of the new truck that will be entered into during the 2026 year.

The 2026 proposed annual budget is in compliance with the property tax levy cap.
