If more space is needed, multiple spaces must be purchased accordingly. **Pre-payment is required along with pages 1 & 3 of this application completed and signed.** No spaces are reserved without the completed application and payment in full. You need to be available for both advertised dates. **No refunds will be given unless both dates are cancelled due to inclement weather.**
2. All spaces will be rented on a first come, first serve basis.
3. Participant must provide his/her own tables, chairs and displays. Electricity is NOT available. Since this is an outside event, some type of tent or canopy is recommended, and is not provided. **Canopies cannot be staked down, only sandbag or weights are allowed.**
4. **Spaces will not be assigned. Participants will choose their space based on availability.** We also reserve the right to relocate vendors, if deemed necessary.
5. Set-up times will be approximately 1 Hour before the event starts, specific instructions will be emailed with the details; i.e., set up times, loading and unloading instructions, and any additional information needed.
6. Participant is required to keep his/her space clean and neat. All boxes, signs, trash and debris must be removed before vacating the space at the close of the event.
7. Participant must accept full responsibility for any loss, injury, or damage to persons or personal property that may be sustained while at the event. Buena Vista Township assumes **NO** responsibility.

- NO PRESCRIPTION DRUGS
